The Nā Hōkū Navigator Challenge: ‘Ohana Stargazing Giveaway

GIVEAWAY OFFICIAL RULES

(“Giveaway Rules”)

NO PURCHASE NECESSARY

1. PROMOTION PERIOD:

The Our Kaka’ako (“Our Kaka’ako”) “*The Nā Hōkū Navigator Challenge*” ‘Ohana Stargazing Giveaway (“Sweepstakes”), begins at 6:00 PM Hawai’i-Aleutian Standard Time (“HAST”) on Saturday, October 12, 2024 and ends on Saturday, October 26, 2024 at 11:59 PM HAST (“Promotion Period”).

2. ELIGIBILITY:

The Sweepstakes is open only to legal U.S. citizens (present in Honolulu, HI during the Promotion Period) who are 18 years of age or older and the age of majority as of October 12, 2024. No purchase necessary. The following individuals are ineligible to participate in the Sweepstakes:

- A. Directors, officers, employees, and agents of Kamehameha Schools, Olomana Loomis ISC, Hawaiian Airlines, ‘Imiloa Astronomy Center, SCP Hilo Hotel, Bishop Museum and their subsidiaries, affiliates, and advertising and promotional agencies.
- B. The immediate families of the group in section 2.A., including, but not limited to, their spouses, children, siblings, parents, in-laws, grandmothers, grandfathers, grandchildren and any spouse thereof.
- C. A person residing in the same household as any of the groups in sections 2.A. through 2.B.

3. SPONSOR:

The Sponsor is Olomana Loomis ISC, Inc. (“OLISC”), 900 Fort Street Mall, Ste. 1548, Honolulu HI 96813.

4. HOW TO ENTER:

- Entrants must collect all 6 stars on their Nā Hōkū Navigator Challenge card and show it to an Our Kaka’ako representative at the event registration booth.
- Entrants will need to provide their name and email to enter the Sweepstakes.

To enter without participating in the navigator challenge, write your full name, daytime and evening telephone numbers, email address, valid residential address (no P.O. Box addresses) on a piece of paper and mail by 11:59 PM HAST on Monday, October 14, 2024 to the Our Kaka'ako Info Center at 660 Keawe St, Honolulu, HI 96813. Each valid entry made on paper will be entered into the drawing and shall be voided thereafter. Mass produced, mechanically/digitally produced, machine printed, illegible or typewritten entries will not be accepted.

All entries become the sole and exclusive property of the Sponsor and receipt of entries will not be acknowledged or returned. Sponsor will not be responsible for entries excluded or deemed ineligible due to reasons beyond their control, including, but not limited to, lost, late, mutilated, incomplete, illegible, or unintelligible entries, or technological failures of any kind, or reasons due to the method of delivery or service.

Entries are limited to one per person regardless of method of entry.

5. RANDOM DRAWING AND PRIZE:

Prize ("Prize"): There will be (1) grand prize and (1) first prize available:

- (1) Grand Prize winner will receive:
 - 120,000 HawaiianMiles, valued at approximately \$1,200. HawaiianMiles terms and conditions apply.
 - 1 weekend pass to 'Imiloa Astronomy Center
 - 1 night stay in a deluxe room at SCP Hilo Hotel. Accommodations are based on single or double occupancy. Subject to availability. Merrie Monarch dates excluded (4/22/25-4/27/25). Expires on 9/15/25.
- (1) First Prize winner will receive:
 - 1 dual/family membership valued at approximately \$120. Membership includes general admission and parking for up to two named adults, plus up to six children under the age of 18. Bishop Museum terms and conditions apply.

Winners will be selected in a random drawing conducted by Olomana Loomis ISC from among all eligible entries received on or about Monday, October 28, 2024. Odds of winning are dependent upon the number of eligible entries received. The potential winners will be notified via an email from an OLISC representative. At the sole discretion of the Sponsor, an alternate winner may be drawn in the event Olomana Loomis ISC is unable to contact the potential winner or if the potential winner does not respond within 48 hrs of drawing or is ineligible.
